**1. GENERAL**

**1.001** This addendum supplements Section 314-984-300, Issue 1. Place this pink sheet ahead of Page 1 of this section.

**1.002** This addendum is issued for the following reasons:

(a) To replace the term and abbreviation Digital Network Administration Center (DNAC) with Norway Facility Management Administration Center (Norway FMAC) or National Technical Support Center (NTSC) or Operational Support Center (OSC), depending on the specific functional responsibility

(b) To delete a sentence from paragraph 6.07.

**2. CHANGES TO SECTION**

**2.001** On Page 16 in paragraph 4.31, replace DNAC with Norway FMAC.

**2.002** On Page 17, revise paragraph 4.36 as follows:  
The data-base manager is located at the Norway FMAC and uses a DATASPEED® terminal set (cathode-ray tube/keyboard with associated printer) for interaction with the minicomputer. The primary responsibility of the data-base manager is to coordinate activities to update the data base at the minicomputer. The responsibilities are defined in Section 314-984-101.

**2.003** On Page 17 in paragraph 4.38, replace DNAC with FMAC.

**2.004** On Page 18, revise paragraph 6.01 as follows:

The following troubleshooting information assumes the minicomputer center is functioning properly. Any problems involving DTSS other than the minicomputer will most likely involve the participation of the technician at the NTSC. Such problems may include the SU(s) located in DDS office(s), the cabling from the minicomputer via the DSX-OB to the DDS office, the report distribution terminals located at the FMACs, Network Operations Center (NOC), Centralized Test Centers (CTCs), and the connecting multipoint data circuits for report distribution.

**2.005** On Page 18 in paragraph 6.03, replace DNAC with OSC.

**2.006** On Page 19 in paragraph 6.07, replace DNAC with NTSC and delete the fifth sentence.

**2.007** On Page 20 in paragraphs 6.10, 6.12, and 6.17, replace DNAC with NTSC.

**2.008** On Page 21 in paragraphs 6.20 and 6.21, replace DNAC with NTSC, SSC/CTC with CTC, and Regional Facility Management Administration Centers with FMACs.

**2.009** On Page 22 in paragraph 6.22, replace DNAC with OSC.

**2.010** On Page 22 in paragraph 6.23, replace DNAC with NTSC.
