TELEPHONE SETS

881A105, 881A106, 881A107, 881A108, 881B105, 881B106, 881B107, AND 881B108

1. GENERAL

1.01 This section provides identification, installation, and connection information for the DESIGN LINE* telephone sets (*Candlestick***) (Fig. 1).

1.03 The customer's premises must be properly wired with an appropriate connecting block or jack in order to accept the D4BU-29 plug-ended mounting cord or 225A adapter furnished with each telephone set.

2. **IDENTIFICATION**

2.01 The 881A105, 881A106, 881A107, and 881A108 (rotary dial) equipped telephone sets are new DESIGN LINE telephone sets being made available to the customer. ▶The 881B105, 106, 107, and 108 telephone sets, are the (rotary dial) equipped modular telephone sets.◆ The customer buys the housing from the telephone company and




Fig. 3—▶Telephone Company-Owned Components.

the telephone company retains ownership of the transmission and signaling components. (Fig. 2 and 3).

Ordering Guide (Refer to Table A)

2.02 Basic Telephone Set Ordering Information:

Example: Set, Telephone, 881A105† is a black set equipped with a rotary dial (Fig. 1).

2.03 These telephone sets are intended to be used as single line or two-party desk sets and are not recommended for use on four- and eight-party service.

3. INSTALLATION AND CONNECTIONS

- 3.01 These telephone sets are furnished from the factory fully assembled and wired for bridged ringing. To connect the telephone set, plug the mounting cord into a 625A jack or if the existing jack is a 548A or equivalent, use the 225A adapter furnished with each set.
- 3.02 The internal connections for the 881A- and 881B-type telephone sets, for nonkey system use, are shown in Fig. 7 and 9.
- **3.03** Connections for 1A KTS do not require any telephone set modifications and are wired same as Fig. 7.
- 3.04 Connections for use with 1A1 or 1A2 KTS are shown in Fig. 8 and 10. Table C includes necessary wiring modification required for 1A1 or 1A2 key telephone system use.
- **3.05** To gain access to the interior of these sets for wiring changes, refer to Part 4.

3.06 Line and Ringer Connections:

- For single line and two-party service, refer to Table B.
- (2) For adjustments and ringer cutoff feature of the P1A ringer, refer to Section 501-259-101.

4. REMOVAL OF TELEPHONE COMPANY-OWNED COMPONENTS

4.01 When it is desired to discontinue telephone service of these DESIGN LINE telephone sets, proceed as follows:

Note: Remove telephone company-owned components that can be easily removed. Refer to Fig. 3 for identification of company-owned components.




Fig. 4—881A105, 881A106, 881A107, or 881A108 Telephone Set, Bottom View

- (1) Remove four base mounting screws from the bottom of the telephone set and remove bottom base (Fig. 4).
- (2) Remove one dial frame and two line switch mounting screws from the base and remove dial frame and line switch (Fig. 5).




Fig. 6—Removing Dial, Network, and Ringer

- (3) Remove one network, two ringer and three dial mounting screws from the base and remove network, ringer and dial (Fig. 6).
- (4) Unscrew transmitter and receiver caps and remove T1 transmitter and U3 receiver units.
- (5) Replace dial frame and base using four screws removed in Step (1), see Fig. 4.
- **4.02** Follow local procedures for returning telephone company-owned components.
- 4.03 When it is desired to return a set to Western Electric for repair, it should be packed using the D-180600 Kit of Parts which contains packing materials and instructions




Fig. 7-881A105, 881A106, 881A107, or 881A108 Telephone Set, Connections




Fig. 8-811A105, 881A106, 881A107, or 881A108 Telephone Set Wired for 1A1 or 1A2 KTS




Fig. 9-\$81B105, 881B106, 881B107, or 881B108 Telephone Set, Connections




Fig. 10—\$881B105, 881B106, 881B107, or 881B108 Telephone Set Wired for 1A1 or 1A2 KTS4
